1. Call to Order - Greg Walker (CABA)

Yann Kulp (Schneider Electric) announced Larry Ehlinger (Pella Corporation) as a new CHC Vice-Chair and commented that he will be great addition to the team.

3.2 Motion to approve Past CHC Minutes - Yann Kulp (Schneider Electric)

Yann Kulp (Schneider Electric) informed everyone that the meeting minutes from the October, 2015, CHC meeting were circulated and were posted on the CABA website in the CHC section: http://www.caba.org/chc.

4. Research Update - Larry Ehlinger (Pella Corporation)

4.1 "Cybersecurity and the Connected Home" Landmark Research - Larry Ehlinger (Pella Corporation)

A brief overview of this \$150,000 USD research project was given. This "Cybersecurity and the Connected Home" research project is being conducted by Frost & Sullivan. CABA, Frost & Sullivan and the CHC are actively seeking additional funders for this project and a request for funders was made. The full

4.2 Vote results and selection of "Connected Multi-Dwelling Units (MDUs) and IoT" as the next CHC Landmark Research - Larry Ehlinger (Pella Corporation)

Larry Ehlinger (Pella Corporation) led the discussion on the next CHC Landmark research project that CABA should undertake in 2016. Larry announced that "Connected Multi-Dwelling Units (MDUs) and IoT" was selected by the CHC Executive Committee after learning that it was the top choice in a CABA members survey.

Motion to approve "Connected Multi-Dwelling Units (MDUs) and IoT" as the next CABA CHC Landmark research project for 2016 was moved by Derek Cowburn (Lumen Cache, Inc.), the motion was seconded by David Katz (Sustainable Resources Management Inc.). Unopposed motion passed.

5. <u>CHC White Paper Sub-Committee (WPSC) Update</u> - Derek Cowburn (Lumen Cache, Inc.)

An overview was given of the CHC White Paper review process, completed CHC white papers, and papers in progress. CHC white papers are secondary literature review articles that are approximately 10-20 pages in length. These papers are written and distributed free of charge to educate the industry. In order for the papers to be approved by the CHC White Paper Sub-Committee (WPSC), they must be applicable to the CHC, not marketing material, and not promote an agenda. Any CABA member can, and is encouraged to, bring forward a 1-2 paragraph white paper proposal to the WPSC. If needed, CABA will secure a writer and/or a working group for the paper. All completed and approved CHC white papers are placed in the CABA Public Library, Members Library, CABA NewsBrief, and promoted at industry events. Derek Cowburn (Lumen Cache, Inc.) gave an overview of this paper. Leo Valiquette (CPEIA) mentioned that the final draft will be completed in about two (2) weeks.

5.3 Call for CHC White Paper Sub-Committee Volunteers and new CHC White Paper Topics

Derek Cowburn (Lumen Cache, Inc.) made a call for CHC White Paper Sub-Committee Volunteer(s).

Susan Cohen (Support.com) proposed a white paper topic on customer adoption and returns, issues related to installation and support.

Roy Perry (Alarm.com) proposed a topic on supportability. He mentioned that supportability is just as important as interoperability in driving the market forward.

Yann Kulp (Schneider Electric) proposed a white paper topic on the emergence of speech to control home automation systems.

6. CES (Consumer Electronics Show Overview Discussion from a Connected Home Perspective (20 min) - Yann Kulp (Schneider Electric)

Yann Kulp (Schneider Electric) led the general discussion on new and interesting connected home products from the CES Show. Yann mentioned that Schneider Electric sent 12 individuals to the show and it was a great event. Yann mentioned four (4) key takeaways from the event: 1) The first mover in a category has the strongest staying power, 2) Speech control is becoming very important, 3) The channel of how a product is sold is critical, including access to the market and access to the customer, and 4) there is a dramatic increase in the number of start-ups in the space.

Ken Wacks (Ken Wacks Associates) talked about the size (3,800+ exhibiters) and layout of the event. Ken noted the presence of an increasing number of start-ups in recent years. Ken noted consumer privacy was addressed for the first time and he mentioned TV technologies, like quantum dots and high dynamic range (HDR).

Melissa Simpler (Affinegy, Inc.) noted the Samsung announcement that all their smart TV and smart refrigerators will be incorporating smart hubs. She also noted the presence of Amazon and the Echo platform solutions.

Ron Zimmer (CABA) commented on the many great side events, including the CONNECTIONS Summit and an event focusing on cybersecurity and privacy.

Roy Perry (Alarm.com) noted concierge services of professional monitoring organizations that use a central station.

Derek Cowburn (Lumen Cache, Inc.) talked about the waves and crashes of the home automation industry over the years. He commented on the problem of the lack of reliability in products, specifically those originating from China.

David Katz (Sustainable Resources Management Inc.) mentioned the strong presence of electric and connected cars at CES this year.

Alex Kim (Robert Bosch LLC) had a question to the group about the impact and market size of DIY vs. professional installation solutions. Roy Perry (Alarm.com) responded that there is and will likely be a mix of both in the connected home space.
